


**NOTIFICATION**

**GUJARAT CIVIL COURTS ACT, 2005.** No.GK/38/2015/CCA/102014/1113/D, (Part 11) :- In exercise of the powers conferred by sections 5, 7 and 11 of the Gujarat Civil Courts Act, 2005 (Guj.21 of 2005), the Government of Gujarat, in consultation with the High Court of Gujarat, with effect from the 2<sup>nd</sup> November, 2015 establishes the full time Court of Senior Civil Judge, as follows, namely:-

1. The Court of Principal Civil Judge, Visnagar shall be treated as Court of Additional Civil Judge, at **Visnagar** in **Mahesana** District;
2. There shall be a Court of Senior Civil Judge at **Visnagar**, subordinate to the District Court, **Mahesana**;
3. The said Court shall be presided over by the Principal Senior Civil Judge, who shall hold his Court at **Visnagar**;
4. The local limits of the ordinary jurisdiction of the Court of Senior Civil Judge, **Visnagar**, shall consist the areas of villages of **Visnagar, Vadnagar, Kheralu, Satlasna** and **Unjha** talukas of **Mahesana** District;
5. The local limits of **Visnagar, Vadnagar, Kheralu, Satlasna** and **Unjha** talukas shall be excluded from the local limits of ordinary jurisdiction of the Court of Principal Senior Civil Judge, **Mahesana**.
